AGM 24th September 2019

Welcome:

Maire Ni Cleiridh (vice chairperson) welcomed parents to the AGM. She explained that every parent is a member of the PA and that all funds raised directly benefit the students in the school. She made a presentation covering the functions, events and fund raising activities undertaken by the PA throughout the year, including the Debs reception, careers nights, 1st year parents night, book fairs, table quiz, parents lunch and assistance at school events, eg. TY show, graduation etc.

She drew attention to the list provided to parents of item funded by the PA for the school during the past year, including workshops, science, music, PE and HomeEc equipment.

She encouraged parents to become involved in the PA, explaining that a variety of events occur during the year and that helpers are always needed. There are 9 meeting a year, currently then are on alternative Tuesdays and Wednesdays at 8 pm in the school. It is a very friendly and inclusive environment.

FINANCIAL REPORT:

The Income and Expenditure account for the year to 30 June 2020 was presented by the treasurer, Clarissa Bryans.

PRINCIPAL'S REPORT:

DG welcomed parents. DG presented a summary of a report made to Le Cheile. She stated the enrolment was 638 for 19/20. The following policies were reviewed by the school and Board of Management during 18/19:

- Admissions policy
- Child Protection policy
- Anti bullying
- Dignity in the workplace
- Data protection
- School tour policy

Under the Summer Works scheme, the windows to the front of the school were replaced at a cost of €130k. The school building has undergone major refurbishment during last 10 years. Since 2002, more than €5 million has been spent. School is now moving into Phase 2 to identify and prioritise areas for upgrading.

Audited accounts for the school have been submitted to Le Cheile Trust.

DG thanked the PA for their help and support to her and to the school over the past year.
